JUNE 2013 SMC SUMMARY REPORT

1.0 MINUTES AND ACTION ITEMS

The minutes of the May 6, 2013 SMC meeting were approved and adopted as read, and the action list was reviewed and updated.

2.0 DECISION

SIAST Lean Priority Project for 2013-14

Interim provost & VP, Academic Boldt and AVP, Strategy Management Neufeld presented to SMC the SIAST Lean Priority Project for 2013-14 with the request that SMC select the SIAST Student Registration process as its main strategic Lean value stream for 2013-14. SMC endorsed and the president approved the SIAST Lean Priority Project for 2013-14 as presented.

Information Technology Governance Proposal

Interim VP, ASC Schmitz & AVP, ITS McCormick presented the proposed Information Technology Governance model for approval by SMC. SMC endorsed and the president approved the Information Technology Governance model as proposed, with revisions discussed.

SIAST Planning Process for 2014-15

Interim provost & VP, Academic Boldt & AVP, Strategy Management Neufeld presented to SMC the SIAST Planning Process for 2014-15 Operating & Capital Plan for approval. Primary Care Nurse Practitioner Advanced Certificate: Program Suspension

The SIAST Nursing Division has entered into a partnership with the University of Regina, Faculty of Nursing to offer a Master of Nursing (Nurse Practitioner) graduate education program, which necessitates suspension of the PCNP advanced certificate program. The program will accept applications for August 2013. SMC endorsed and the president approved the Primary Care Nurse Practitioner Advanced Certificate program suspension.
