#### 1.0 General

#### 1.1 March 5, 2014, Report Review and Action List

The minutes of the March 5, 2014 SMC meeting were approved and adopted as read, and the action list was reviewed and updated.

#### 2.0 For Decision

# 2.1 Policy A 2.1 Academic Accommodation for Students in the Reserve Forces

Provost & VP Academic Neufeld presented to SMC the revised Policy A 2.1 Academic Accommodation for Students in the Reserve Forces for approval. The Canadian Armed Forces consists of regular and reserve soldiers, sailors and air personnel. Approximately 40% of Canada's reserve force is students, of which the majority are enrolled in post-secondary education. Military service in the reserve forces provides students with a variety of transferable skills and practical work experiences. The Canadian Forces Liaison Council encourages educators and employers to recognize the benefits of supporting the part-time military careers of their students and employees, and to take active steps to do so. Revising this policy in support of student reservists helps resolve common and regularly occurring problems which reservists encounter when they seek to balance their military service requirements with education. This policy recommends SIAST actively consider accommodating student reservists with meeting military obligations. While accommodations will be considered, the granting of accommodations should not adversely affect the quality of the student's studies at SIAST. SMC endorsed and the president approved the revised Policy A 2.1 Academic Accommodation for Students in the Reserve Forces as presented.

#### 2.2 Policy G 3.3 Tuition and Fees and 2014-15 Student Fee Schedule

Provost Neufeld presented to SMC for approval the revised Policy G 3.3 Tuition and Fees, and the 2014-15 Student Fee Schedule for approval. Following much discussion regarding these items it was determined that Appendix D will be revised to include: International students and Continuing Education programs will be charged published tuition rates. SMC endorsed and the president approved the revised Policy G 3.3 Tuition & Fees, and the 2014-15 Student Fee schedule with the revisions recommended.

# 2.3 Policy O 2.3 Employee Complaints

CFO & VP Administrative Services Schmitz presented to SMC Policy O 2.3 Employee Complaints for approval as part of the policy review schedule. SMC endorsed and the president approved Policy O 2.3 Employee Complaints as presented.

#### 2.4 Civil Technician Certificate Implementation Proposal

Provost Neufeld presented to SMC for approval the implementation of the Civil Technician Certificate program effective July 1, 2014. It will provide 34 week/840 hour training for students interested in a support role to technologists, engineers and scientists, and will have an annual fall intake of 16 students at the Palliser Campus. This new certificate program has been vetted through the 2014-15 OCP. SMC endorsed and the president approved the implementation of the Civil Technician Certificate Implementation as presented.

#### 2.5 Saskatchewan Forum 2014 SIAST Complimentary Registrations

Provost Neufeld presented to SMC for approval the six candidates recommended for the May 27-28, 2014 Saskatchewan Forum Complimentary registrations for SIAST. The six registrations recommended will include: Dr. Rosia, Dr. Neufeld, Cheryl Schmitz, Cristina Holguin-Pando, and that two other representatives who will be selected by Dr. Neufeld. SMC endorsed and the president approved the recommended Complimentary Registrants for the 2014 Saskatchewan Forum as presented.

#### 2.6 First Nations University Property Lease

CFO Schmitz and AVP Fachada presented to SMC for approval a draft letter for the Ministry of Advanced Education (AE) requesting acquisition of the downtown Saskatoon First Nations University property. SMC endorsed and the president approved the letter to the Ministry of Advanced Education requesting acquisition of the First Nations University property as drafted with the inclusion of the revisions discussed.

#### 3.2 Kelsey Expansion Presentation

CFO Schmitz introduced members from the Stantec team. Stantec representatives provided a detailed presentation regarding the Kelsey Expansion. SMC received and endorsed the Kelsey Expansion Presentation which was provided.

#### 3.3 SIAST School of Architecture

CFO Schmitz and AVP Fachada presented to SMC for information and endorsement the proposal for further discussion and planning related to a SIAST or joint SIAST / U of R School of Architecture. A specific location has been identified in downtown Saskatoon for the housing of this school. The Saskatchewan Architectural Association has approached SIAST for support of this School. The degree requisite in this field would be the Masters of Architecture. SMC received and endorsed recommendation for further discussions and planning for a SIAST School of Architecture.

SMC deliberated over this request and determined that approval cannot yet be provided based on the fact that the new name has not yet been proclaimed in the Legislature. This response will be communicated through a letter from Dr. Rosia. SMC received for discussion the request of the Students' Association SIAST Wascana Campus Request.
