## Power Engineering Sponsorships

*The purpose of the Husky Energy Power Engineering Sponsorship is to support the educational efforts of outstanding students seeking a career in Power Engineering.*

**Award Value:     \$15,000**

### **Eligibility Criteria:**

- ☐ Be enrolled in the 2 year Power Engineering Technology diploma program at Saskatchewan Polytechnic Saskatoon campus for the 2019 – 2021 academic years.
- ☐ Have an acceptable attendance record.
- ☐ Provide a letter of reference which can be from a previous employer or a high school teacher. Letter of reference should address the character, commitment and ability of the applicant to work in a team environment.
- ☐ Provide an updated resume, transcript, and cover letter outlining why you chose to study power engineering, why you should be selected for the sponsorship, and how you would be an asset to the Husky organization.
- ☐ Willingness to accept additional terms/conditions as specified by Husky Energy Inc.
- ☐ Willingness to accept employment with Husky Energy Inc. (Husky maintains the right to not offer employment after graduation).
- ☐ **Be recommended by Husky Energy for consideration as a recipient of the scholarship after a formal interview with representatives of Husky Energy.**

### **Selection Criteria:**

- Academic achievement based on marks from Year One of the Power Engineering Technology program.
- A selection committee will be comprised of members from Husky Energy and will include a formal interview process. At that time you will be required to provide an official Saskatchewan Polytechnic transcript to Husky Energy.
- Accept summer student employment at a Husky facility upon completion of year one
- Eligible to work full-time in Canada
- Have and maintain a valid full Class 5 (or similar Canadian equivalent) driver's license
- One scholarship per year may be designated to a student of self-declared Indigenous ancestry. Preference will be given to qualified applicants of self-declared Indigenous ancestry in the following priority: applicants with permanent address in Saskatchewan, second with permanent address outside of Saskatchewan.
